# **Intended Learning Outcomes (ILO)**

Upon completion of the course the student should have the:

# Knowledge and understanding

- in an advanced way problematize concepts like social policy, welfare, participation and citizenship in relation to a welfare society in transition and from an international perspective
- analyse perspectives on disability, ageing and ethnicity and the impact of these perspectives for social work practise and for individual opportunities in the society.

#### Skills and abilities

- identify problems, develop and take advantage of resources and also change living conditions for people through empowerment and social mobilization within social work practice
- problematize and analyse the interplay between societal processes on structural level and individual living conditions of importance for civic engagement
- problematize and scrutinize in a critical way participation in connection with planning and implementing social support.
